TALOSA WINE CLUB REGULATIONS

Terms and Conditions

1) Introduction

The "Talosa Wine Club" is an initiative of the Fattoria della Talosa Limited Liability Agricultural Company (C.F. and P.I. 00136070521), with registered office in Montepulciano (SI), Via Talosa n. 8, which consists of an annual subscription and provides its members with numerous benefits, including advantageous discounts and exclusive reserved experiences. These regulations contain the terms and conditions that govern the methods of registration/adhesion and the benefits that being part of it entails.

2) Who is the Wine Club for?

Any natural person who has reached the age of eighteen at the time of joining the Wine Club can join/subscribe to the wine club.

3) How to join "Talosa Wine Club"

Membership in the "Talosa Wine Club" is recognized by subscribing to one of the annual subscriptions provided – and as indicated in detail below – and therefore against the purchase of a predetermined number of bottles of wine produced by the Fattoria della Talosa Società Agricola a Responsabilità Limitata.

Membership in the "Talosa Wine Club" implies the member's acceptance of the Wine Club Regulations and therefore of the terms and conditions indicated herein. Once the chosen subscription has been subscribed and paid, the member will receive an e-mail confirming that the subscription has been completed.

4) Types of subscriptions and reserved benefits

The "Talosa Wine Club" offers four types of subscriptions.

A) **VIP – PRIVILEGE:** *"The ultimate in refinement. A privilege designed for those who want the best of Talosa: unobtainable vintages, exclusive reserves, private experiences in the most evocative places of the estate. Only for true connoisseurs".*

Membership in this type of annual subscription is recognized against the purchase of 36 bottles of wine from Fattoria della Talosa for a total price of € 2,690.00.

The following bottles of wine are included in the subscription in question:

- 4 bottles – Nobile di Montepulciano DOCG;
- 4 bottles – Nobile di Montepulciano Riserva DOCG;
- 6 bottles – Nobile di Montepulciano "Filai Lunghi" DOCG;

- 6 bottles – Toscana Rosso IGT "Pietrose";
- 2 bottles – Nobile "Pieve Le Grazie" Riserva Chiusino DOCG;
- 2 bottles – Nobile "Pieve Le Grazie" Riserva Chiusino Old Vintage;
- 4 bottles – Vin Santo di Montepulciano DOC 2004;
- 4 bottles – Toscana Bianco IGT "Pietrose";
- 4 bottles – Toscana IGT "Pietrose" Spumante.

The bottles of wine will be delivered via two annual shipments. In this regard, it should be noted that shipping costs in the United States (U.S.A.) and in the member states of the European Union (E.U.), as well as those for any customs duties and/or tariffs, are included in the cost of the annual subscription. As for shipments to any other country, the interested party is invited to contact the staff of Fattoria della Talosa, at the e-mail address wineclub@talosa.it, in order to have any information and / or clarification on the matter.

Joining the VIP – PRIVILEGE membership will entitle you to the following benefits, namely:

- 15% discount voucher to be applied on every single transaction relating to the purchase of wines and / or any other product of Fattoria della Talosa, including Old Vintages wines, made at the online shop of Fattoria della Talosa or at the Wine Shop of the same, located in the historic center of Montepulciano (Not including any shipping costs, as well as those for tariffs and duties, which will then be charged to the Club member who wishes to take advantage of this benefit);
- 15% discount voucher to be applied to the cost of the Wine Tour "*Talosa Experience*" (experience that includes a visit to the Vineyards of the Fattoria della Talosa + a visit to the Historic Cellar located in the historic center of Montepulciano + a VIP Lunch);
- 15% discount voucher to be applied to the cost of stays at "Villa Talosa" (the discount voucher will be valid for only 1 stay per year);
- possibility to participate in an exclusive truffle hunt or, alternatively, in a private dinner;
- possibility of taking advantage of the assistance and advice of a wine expert (any request for assistance must be received exclusively by e-mail to the wineclub@talosa.it address and the expert will respond within the following 48 hours);
- a private welcome letter signed by the owner of the Fattoria della Talosa, together with the membership card of the "Talosa Wine Club" (Membership Card).

It should be noted that the aforementioned benefits must be used no later than the expiration of the annual subscription. After the aforementioned term, it will therefore no longer be possible to use the same for each member of the club.

Membership in this type of annual subscription is recognized against the purchase of 24 bottles of wine from Fattoria della Talosa for a total price of € 1,490.00.

- 2 bottles – Toscana IGT "Pietrose" Spumante;
- 2 bottles – Nobile "Pieve Le Grazie" Riserva Chiusino DOCG;
- 2 bottles – Vin Santo di Montepulciano DOC 2004.

The bottles of wine will be delivered via two annual shipments. In this regard, it should be noted that shipping costs in the United States (U.S.A.) and in the member states of the European Union (E.U.), as well as those for any customs duties and/or tariffs, are included in the cost of the annual subscription. As for shipments to any other country, the interested party is invited to contact the staff of Fattoria della Talosa, at the e-mail address wineclub@talosa.it, in order to have any information and / or clarification on the matter.

Joining the SELEZIONE – EXCLUSIVE subscription will entitle you to the following benefits, namely:

- 15% discount voucher to be applied to every single transaction relating to the purchase of wines and/or any other product of Fattoria della Talosa, including Old Vintages wines, made at the online shop of Fattoria della Talosa or at the Wine Shop of the same, located in the historic center of Montepulciano (N.B.: any shipping costs are not included, as well as those for tariffs and duties, which will then be charged to the Club member who wishes to take advantage of this benefit);
- 10% discount voucher to be applied to the cost of the Wine Tour "*Talosa Experience*" (experience that includes a visit to the Vineyards of the Talosa Farm + a visit to the Historic Cellar located in the historic center of Montepulciano + a Lunch);
- 10% discount voucher to be applied to the cost of stays at "Villa Talosa" (the discount voucher will be valid for only 1 stay per year);
- possibility of taking advantage of the assistance and advice of a wine expert (N.B.: any request for assistance must be received exclusively by e-mail to the wineclub@talosa.it address and the expert will respond within the following 48 hours);

- 2 bottles – Nobile di Montepulciano Riserva DOCG;
- 3 bottles – Toscana Rosso IGT "Pietrose";
- 3 bottles – Toscana Bianco IGT "Pietrose";

-2 bottles – Toscana IGT "Pietrose" Spumante.

Bottles of wine will be delivered via a single annual shipment. In this regard, it should be noted that shipping costs in the United States (U.S.A.) and in the member states of the European Union (E.U.), as well as those for any customs duties and/or tariffs, are included in the cost of the annual subscription. As for shipments to any other country, the interested party is invited to contact the staff of Fattoria della Talosa, at the e-mail address wineclub@talosa.it, in order to have any information and / or clarification on the matter.

Membership in this type of annual subscription is recognized against the purchase of 12 bottles of wine from Fattoria della Talosa for a total price of € 490.00.

The following bottles of wine are included in the subscription in question:

- 5 bottles – Nobile di Montepulciano DOCG;
- 4 bottles – Nobile di Montepulciano Riserva DOCG;
- 3 bottles – Nobile di Montepulciano "Filai Lunghi" DOCG.

Bottles of wine will be delivered via a single annual shipment. In this regard, it should be noted that shipping costs to the United States (U.S.A.) and to the member states of the European Union (E.U.) as well as those for any customs duties and/or tariffs, are included in the cost of the annual subscription. As for shipments to any other country, the interested party is invited to contact the staff of Fattoria della Talosa, at the e-mail address wineclub@talosa.it, in order to have any information and / or clarification on the matter.

Joining the WELCOME – LE ORIGINI subscription will entitle you to the following benefits, namely:

- 10% discount voucher to be applied to the cost of the wine tour/visit of the Historic Cellar, located in the historic center of Montepulciano;
- possibility of taking advantage of the assistance and advice of a wine expert (N.B.: any request for assistance must be sent exclusively to the e-mail address wineclub@talosa.it and the expert will respond within the following 48 hours);
- a private welcome letter signed by the owner of the Fattoria della Talosa, together with the membership card of the "Talosa Wine Club" (Membership Card).

It should be noted that the aforementioned benefits must be used no later than the expiration of the annual subscription. After the aforementioned term, it will therefore no longer be possible to use the same for each member of the club.

5) Events and activities

The methods of participation in the organized events/activities, Wine tours and exclusive reserved experiences must be managed by private communication to the Wine Club manager at the e-mail address wineclub@talosa.it.

Inappropriate conduct is not tolerated during the events/activities organized.

6) Membership card to the "Talosa Wine Club" (Membership card)

The "Talosa Wine Club" Membership card is nominal and personal and therefore cannot be transferred and/or transferred to third parties.

However, the member is allowed the possibility of having third parties use each of the individual benefits granted to him, subject to compliance with the following formality: the member must contact, by e-mail to the address wineclub@talosa.it, with at least 7 days' notice, the staff of Fattoria della Talosa indicating the details of the person who will use the benefit in his place.

The Membership Card is renewed annually as a result of the renewal of the annual subscription to the "Talosa Wine Club".

The presentation of the valid Membership Card allows members to benefit from the discount coupons provided in the various types of subscription and highlighted in detail in art. 4) above.

7) Subscription Duration

The subscription will last one (1) years from the date of its subscription (and therefore from the moment of joining the Wine Club) and will be automatically renewed from time to time for the same period, unless cancelled by the member which must be communicated to Fattoria della Talosa by email to the email address wineclub@talosa.it no later than thirty days before the day on which the automatic renewal will take place.

The staff of Fattoria della Talosa will provide, at least sixty days before the day on which the automatic renewal of the subscription will take place, to send each member of the club a special alert e-mail to remind them of the automatic renewal of the subscription and therefore of the registration / membership of the Wine Club.

In the event of automatic renewal of the subscription and therefore if the member does not send the notice of cancellation within the peremptory terms indicated above, no refund of the fee will be made by Fattoria della Talosa.

8) Payment methods

The payment of the subscription must be made at the same time of its subscription. In default of payment, Fattoria della Talosa will not activate the chosen subscription.

Each payment can be made by credit card (Visa, Mastercard, American Express) or by PayPal or Stripe.

The payment of the individual benefits included in the various subscriptions can also be made *on site* at the offices of the Fattoria della Talosa.

9) Rights and Duties of the Member

Each member of the Club has the right:

- to take advantage of all the benefits recognized on the basis of the type of subscription subscribed to and as better specified in art. 4) above. However, it should be noted on this point that the aforementioned benefits: i) must be used by the expiration of the annual subscription, with the consequence that after this term it will no longer be possible to use them for each member of the club; ii) they cannot be replaced or converted into cash, nor are Wine Club members allowed to request, with or without the addition of sums of money, benefits other than those mentioned above;
- to take advantage of private assistance. Any request must be sent by e-mail to the e-mail address wineclub@talosa.it. A member of the staff of the Fattoria della Talosa will process the request within the next 48 hours;
- in the event of damage, during shipping, to one of the bottles of wine included in the type of subscription chosen, to ask for its replacement or, alternatively, to obtain a refund equal to the cost of the damaged bottle;
- to participate in the events/activities organized by the "Talosa Wine Club".

Each member of the Club has the duty and therefore undertakes and obliges to:

- promptly provide for the payment of the chosen annual subscription;
- to maintain appropriate conduct during the events/activities organized;
- respect other members of the "Talosa Wine Club" community;
- respect these regulations of the "Talosa Wine Club".

10) Limitations and exclusions from the Wine Club

Fattoria della Talosa will proceed to exclude the member from the Wine Club and/or cancel his/her registration/membership and possibly also cancel the benefits acquired, in the following cases:

- fraudulent actions or attempts at fraud and theft;
- in case of misleading and/or improper use of the "Talosa Wine Club" program;
- in the event of actions aimed at interrupting the proper functioning of the websites <https://wineclub.talosa.it/> and <https://wineclub.talosa.it/wine-club-talosa/> (websites of the "Talosa Wine Club");
- in cases of failure to pay the annual subscription in a timely manner;
- in the event of suspicious registration by a person previously deleted and/or excluded from the Wine Club;
- in case of non-compliance with these regulations and terms and conditions.

Fattoria della Talosa will also proceed with the exclusion and cancellation of the above if the member does not respect the spaces and other members of the "Talosa Wine Club" community during the events and/or activities organized. In the presence of damage caused, the member assumes responsibility, including financial liability, for the accident.

Any exclusion and/or cancellation will be communicated to the member by e-mail to the e-mail address provided when subscribing to the annual subscription.

11) Communications

Each member by subscribing to the chosen annual subscription and therefore joining the "Talosa Wine Club" authorizes Fattoria della Talosa to process their personal data, for the purposes of promotion, special offers, marketing, profiling, newsletters, etc., according to the methods and terms indicated in the relevant privacy policy.

The various events/activities organized by the "Talosa Wine Club" will be communicated to each member through a periodic Newsletter, subject to the specific express consent of the member himself.

12) Laws and Jurisdiction

These regulations are governed by Italian law.

For any dispute concerning the interpretation, execution and fulfilment of these regulations, the Court of Siena shall have exclusive jurisdiction.

13) Wine Club Shipping Logistics

In the case of subscription to the "WELCOME – SUPER TUSCAN" and "WELCOME – LE ORIGINI" subscriptions, the bottles of wine included in them will be delivered to members by means of a single annual shipment, which will take place within 30 days of subscription.

On the other hand, in the case of subscription to the "VIP – PRIVILEGE" and "SELECTION - EXCLUSIVE" subscriptions, the bottles of wine included in them will be delivered to members by two shipments per year, which will take place respectively within 30 days of subscription and by 1 October.

With specific reference to the "VIP – PRIVILEGE" and "SELEZIONE – EXCLUSIVE" subscriptions, it should also be noted that, if the subscription of the same takes place between 1 October and 31 December, the bottles of wine included therein will be shipped respectively within 30 days of subscription and by 1 April of the following year.

14) Membership-related changes, updates and assistance

For further information on the functioning of the "Talosa Wine Club", for information on annual subscriptions, the Membership card and to take advantage of the various benefits, each member can send an e-mail to the wineclub@talosa.it e-mail address.

Fattoria della Talosa Società Agricola a Responsabilità Limitata reserves the right to modify these Regulations at any time. Any changes made in any case will not affect the rights acquired by the members of the Wine Club. It will be the responsibility and responsibility of the staff of the Fattoria della Talosa to communicate any changes to the Regulations by e-mail to the members of the Club.

The enrollment in one of the annual subscriptions and therefore the registration to the "Talosa Wine Club" will entail for the member the unconditional acceptance of the clauses contained in these Regulations.

15) Disclaimer

Fattoria della Talosa Società Agricola a Responsabilità Limitata does not assume any responsibility in cases of impossibility to take advantage of the benefits indicated above in article 4) for causes beyond its control due to fortuitous circumstances or force majeure or for causes attributable to the members of the Wine Club themselves.
